Minutes of the Meeting of the Parish Council held at Twineham School, Twineham on Monday 13th November 2023 commencing at 7:00 pm

70.23 Apologies for absence were received from Mid Sussex District Councillor G. Zeidler.

71.23 To receive declarations of interest from Members in respect of any matter on the agenda. Councillor Worsley declared an interest in Rampion.

72.23 To approve the Minutes of the Parish Council Meeting held on 7th September 2023. Minutes were agreed by Council and were signed by the Chairman.

73.23 Matters arising from previous Minutes not covered on agenda:

11.1.23 Disposal of fingerposts. Councillor Hirst has taken a £20 donation which will be sent to St. Peter & St. James's Hospice.

74.23 West Sussex County Councillor J. Dennis updated on the following items:

- Real time bus information boards will be installed on both sides of the A23 at Hickstead. Additional bus routes have also been requested.
- Feedback from meeting with Hickstead representatives.

75.23 Update on Highways to include TRO, Hickstead Lane. Council agreed to email residents asking for their views and support for a TRO to implement both a 7.5 tonne weight and speed limit restriction along Hickstead Lane.

76.23 Councillor Hirst highlighted the issues with several footpaths in the parish. Clerk will contact PRO regarding ongoing issues with 14T.

77.23 Council responded to the Rampion 2 consultation on 25th September 2023 highlighting their concerns and requesting changes to the working hours.

78.23 Councillor Hirst and Councillor Murphy recently attended two meetings to update on the Mid Sussex District Plan. These were held on both 14th September and 12th October where a presentation was given by Berkley Homes and Thakeham Homes.

79.23 Councillor Hirst gave an update on enforcement issues.

80.23 Councillor Hirst updated on WSALC as follows.

- Zoom meeting held on 11th October 2023. Items covered included planning and update on office held.

81.23 Update on the Gatwick consultation. Gatwick has submitted a planning application which if approved, would allow the airport to grow from 46 million passengers in 2019 to 80 million passengers per annum. Consultation period will close on 19th November 2023. Clerk has circulated this information to residents.
